IARC2021 STALL APPLICATION

Location

The International Animal Rights Conference 2021 will be held in the Centre Culturel Kulturfabrik Esch at 116, rue de Luxembourg, L-4221 Esch-sur-Alzette, Luxemburg.

Times

Stalls will be open from Thursday, September 2nd, 2021, until Sunday, September 5th, 2021. The exact times will be set several weeks before the conference, but will be roughly the following:

Thursday: 13:30-21:30Friday: 8:30-21:00Saturday: 8:30-21:00Sunday: 8:30-15:30

Besides being open to conference participants, the public can also visit the exhibits.

Setup will be on Thursday, from 10:00 to 13:30, and cleanup will be on Sunday, from 15:30 to 17:30.

Exhibit Space

A standard exhibit consists of a table (height: 73cm, width: 220cm, depth: 50cm) plus a bench. Most, but not all, stall locations are against walls. Spaces are assigned by the conference team, but early registrants get the best picks. Power hookups are available with a maximum of 500 Watts per exhibit.

Prices

The prices are 100 EUR for a commercial stall (either a commercial company stall or a group focusing on selling products) and 40 EUR for nonprofit organizations (mostly providing information instead of selling products).

The stall fee does not include conference registrations, so exhibitors wishing to participate at the conference have to register separately. **Per stall, two full conference registrations at half the price at the time of the registration are possible.**

Pandemic Information

This year the situation is very different from the years 2019 and before. We have no idea how the pandemic will develop leading up to the conference. There is the chance that the conference will still have to be moved to a purely online conference, which would not make stalls possible. Even if the conference is possible with live participants, we expect that strict infection protection measures will have to be implemented. To implement such measures, we can currently only allow fewer stalls. We plan for enough space between the stalls. As we get close to the conference, we might change the conditions. When planning your stall, including the travel and accommodations, please ensure to book only options that can still be canceled if we have to change the conference to an online format.

Rules

None of the literature or other display objects may advocate animal exploitation in any form. None of the products displayed and/or offered for sale may contain animal ingredients or be tested on animals.

No stall may be operated in a manner that detracts from the effective operation of other stalls or the conference. Activity may not extend outside the assigned space. Attaching signs to walls (except for the white backdrop walls) and loud audio is prohibited.

The stall spaces will be pre-assigned and may not be changed or re-assigned without permission by the conference team. Any exhibitor violating these conditions will be offered an opportunity to make the needed correction. If the requested corrections are not met, this may lead to expulsion and forfeiture of fees.

The exhibitor agrees to hold harmless *Save Animals asbl*, the *Centre Culturel Kulturfabrik Esch*, and their employees and agents against any property or other losses or claims arising out of their use of the stall material and premises.
